I am an epidemiologist and health services researcher with nearly 20 years of experience in surgical outcomes research. My work focuses on improving healthcare delivery and outcomes for Veterans and other vulnerable populations, particularly those who are older or medically complex. Using large administrative datasets from the Veterans Health Administration (VA), I study surgical processes and outcomes to inform system-level improvements. With postdoctoral training in health economics and implementation science, I bring expertise in causal inference methodology and artificial intelligence, particularly the use of natural language processing (NLP). I apply these methods to extract insights from unstructured clinical data and to strengthen causal analyses in complex healthcare datasets. These approaches allow me to address research questions that were previously difficult to study with standard empirical approaches.

As a collaborative leader, I have mentored junior investigators and worked across academic and industry sectors to advance health services research. My goal is to translate evidence into practice, ultimately improving the quality of surgical care for Veterans.
