TEACHING EXPERIENCE

Introduction to Sociology. Undergraduate course dealing with basic sociological concepts.

Workshop in Social Stratification. Graduate level seminar organized around faculty and student presentation on topics related to social inequality.

American Indians in Comparative Historical Perspective. Upper level undergraduate focused on historical change in political, economic, and demographic processes, and their impact on White-Indian relations.

American Indians in Contemporary Society. Upper level undergraduate course focused on the sociology of American Indians with a heavy emphasis on demographic, political, and economic developments in White-Indian relations since 1890.

Graduate Seminar in Rural Sociology (1992). "Social Demography of Indigenous Populations", small graduate seminar focusing on comparative and historical demographic processes among indigenous populations.

Graduate Seminar in Rural Sociology (1991). "American Indian Economic Development", small graduate seminar dealing with the special concerns affecting economic development on Indian reservations such as spatial isolation and land tenure.

Introduction to Rural Sociology. Large lecture course dealing with issues affecting rural society.

Introduction to Contemporary Social Problems. Large lecture course with 100-150 students. Lectures covered topics such as poverty, racism, crime, and drug abuse.

Community Organization. Upper level undergraduate course with 30-40 students. Lectures covered sociological theories of community and community development. In group projects, students developed proposals for neighborhood improvement projects and presented them in mock public hearings.

Intermediate Statistics for Sociologists. Required first course in graduate level statistics with 15-20 sociology graduate students. Lectures covered probability theory, theoretical distributions, and hypothesis testing.

Intermediate Procedures of Data Analysis. Required second course in graduate level statistics with 10-15 sociology graduate students. Lectures covered topics related to the General Linear Model such as regression analysis and structural equation models.

Multivariate Statistics. Advanced topics in multivariate analysis. Lectures covered methods of contingency table analysis.
