In partnership with NYC DOHMH, our research team assessed the potential for a minimum price law for sugary drinks to reduce sugary drink consumption, obesity, and obesity disparities in NYC. For the project, I developed and applied a microsimulation model of dietary behaviors and weight outcomes over five years. We then produced an interim report, final report, and policy briefs to provide guidance to NYC about minimum price laws for sugary drinks, including the impact of different policy design options (e.g., higher vs. lower price floors).
- 2019 – 2020 FIRST 5 Santa Clara County
Our team partnered with FIRST 5 Santa Clara County, a nonprofit focused on health and development during the first five years of life, to evaluate a popular children’s book *Potter the Otter: A Tale About Water*. FIRST 5 developed the book to promote healthy beverage consumption among young children and has disseminated the book widely, including through pediatric clinics and the Women, Infants, and Children (WIC) program. We evaluated the impact of this book in a randomized experiment with more than 2,000 parents of children ages 2-5 years. Results showed that exposure to the book promoted healthier attitudes, beliefs, and behavioral intentions regarding the beverages parents serve their children, with no disparities in benefits across population groups. These findings support the continued use of *Potter the Otter* books for promoting healthy beverage consumption.
