This is book length social history of the transition to colonialism in the French Soudan. This project is about the nature of colonialism. Colonialism required the active or passive collaboration of subjected peoples. Force alone was never enough. Colonial subjects and colonial powers entered into bargains of collaboration that changed over time as colonial states evolved. Such bargains of collaboration permitted both "hegemony on a shoestring" and colonial subjects to become bricoleurs, who created new meanings out of cultural and political encounters. This project will examine an individual, Mademba Sy, as he traversed the early phases of colonial rule during which he transformed himself from a telegraph clerk into an African king. It engages in four bodies of scholarship: the cultural and political arts contact zones and middle grounds; bargains of collaboration; bricolage; and the rule of law.
