Uncompensated care

Authorship of legislation which helps provide over \$100 million per year (via surcharge on vehicular moving violations) for emergency medical care of indigent patients by physicians, hospitals, and EMS systems.

Inter-hospital patient transfer



Authorship of legislation which sets standards for the transfer of medically stable patients, and prohibits the economically-motivated transfer of unstable patients. It provides protection for physicians who are forced to transfer unstable patients because of the unavailability of medical consultants or refusal by hospitals to accept patients for admission.

Medical control of emergency medical services

Authorship of legislation which increases physician control over local EMS systems.

Medical standards for free-standing clinics

Authorship of legislation which sets standards for hospital-based and free-standing facilities using the word "emergency" in their names and advertising.

Involvement in other legislative and regulatory activities

Standards for state-certified trauma centers.

Standards for medical helicopter services.

Funding for trauma centers.

Funding for poison control centers.

Law requiring the use of vehicular seat belts.

Law requiring the use of vehicular child restraints.

Law requiring the use of motorcycle helmets.

Law requiring the use of bicycle helmets by children.

Law regulating the conduct of managed care organizations whose patients present to emergency departments.
